



The El Paso Museum of Archaeology is pleased to announce our *2025 Poppies Fest* event taking place on **March 8, 15, 22, and 29, 2025, from 10:00 AM to 3:00 PM**. We are inviting vendors to participate in this month-long celebration with March 8 Reserved for Native American vendors.

Food Trucks who wish to participate in the 2025 Poppies Fest should complete and submit this application form by 5:00 PM on February 15th. Our festival's objective is to feature original arts & crafts, small family-owned businesses and other non-profit organizations. Participants will be selected by a collaborative panel of judges and notified via email. Load-in will begin at 8:30 AM. Vendor parking will be at the Border Patrol Museum with vendors being issued a parking permit for one vehicle. Food Trucks will be required to maintain their operation for the full duration of the event. Additional logistics, maps and instructions will be distributed via email to the selected participants no later than 5:00 PM on March 5th.

We are unable to accept vendor applications from franchise, corporate and large businesses.

Selected food trucks will be charged \$90. All payments must be received by 4:00 PM on March 4th.* Booths & food trucks who have not paid by the March 2nd deadline will have their space given to an alternate vendor. Fees can be paid by cash, check, or credit/debit card (Visa, Discover or Mastercard) in person at the Museum of Archaeology at 4301 Transmountain Road or by phone at 915-212-0421 anytime between 9:00 AM - 4:00 PM, Tuesday-Saturday. You can also pay online on our website <u>https://epmarch.org/</u>. On-site cooking is not permitted at vendor booths. Invited food truck vendors must submit a copy of current food handling and licensing permits with this application. All vendors are responsible for collecting and paying Texas State Sales Tax as applicable to their product. New Mexico residents must apply for a Texas State Sales Tax ID at the local El Paso Comptrollers' office.

Food Truck applicants must include a minimum of 3 digital images with this application reflecting what will be sold. Completed application form, photos, and any applicable food handling and licensing permits must be submitted via email to Diane Vera-Ureño at veraurenoDE@elpasotexas.gov or delivered in person to the Museum by 4:45 PM on February 16th. Late or incomplete applications will not be accepted.
